



Health Plans That Accept Electronic Admission Notifications (278N)

Electronic Data Interchange (EDI) 278N allows inpatient facilities to send electronic admission notifications in standard X12 format. EDI 278N can be sent directly or through a clearinghouse, either as a batch or in real time. Electronic inpatient admission notifications help streamline the admission notification process and lets UnitedHealthcare staff communicate more effectively with care providers and hospital staff.
